# 1.4 Objectives

The Foundation's objective is to:

- increase profitability and sustainability of fresh vegetable production by small-scale vegetable growers in tropical areas in Asia, Africa and Latin America;
- b. position vegetable production as an attractive and viable livelihood;
  - c. contribute to the development of a more healthy and vibrant vegetable sector; and
  - d. improve the livelihood of smallholder vegetable farmers through extension services that provide beneficial and applicable knowledge and information.

The Foundation aims solely to serve the public interest and does not aim to make a profit.

# 1.5 Strategic plan

Vegetables are good. Good for the people who grow them, good for the people who sell them, and good for the people who eat them. East-West Seed helps more people get more varieties of more vegetables than ever before. We do it because we know the impact that vegetables can have for people around the world. While global food security is a topic of major concern in development circles, the reality is that farmers already produce enough food to meet the daily calorie needs of everyone in the world. At the same time, nearly 2 billion people suffer from "hidden hunger," meaning they do not get adequate amounts of vitamins and minerals. This reflects recent research indicating that agriculture currently produces only a third of the recommended amount of fruits and vegetables, and actually over-produces whole grains by 25%. In short, a healthy population needs the nutrients that only vegetables can provide.

Stichting EWS Knowledge Transfer is an independently funded and managed non-profit foundation that seeks to improve the skills, knowledge, and techniques of growers in the most rural, underdeveloped regions in the world. Equipped with advanced agricultural practices, these growers earn bigger yields and higher profits, which sets the stage for long-term market development. Through our Knowledge Transfer work, we train 100,000 farmers each year, giving them the tools, knowledge, and seeds to produce enough vegetables to potentially double per capita consumption for approximately 3 million people. Beyond simply providing more vegetables, these farmers are growing safer, healthier ones using fewer pesticides. Access to quality, affordable vegetables creates healthier families and helps children perform better in school, leading to stronger economies and communities for the long term.

# 1.7 Remuneration policy

Staff compensation follows local employment laws and regulations and is based on competitive local market salary benchmarks.

Key activities include:

## 1. Capacitating farmers

East-West Seed Knowledge Transfer provides in-depth training to selected farmers on a wide range of topics, including:

- Basic agronomy, soil improvement and land preparation
- Seedling production and transplanting
- Pest and disease management
- Nutrient management
- Crop maintenance, harvest and planning

## 2. Demonstration farms

East-West Seed Knowledge Transfer supports key farmers to manage demonstration farms. They receive intensive support. The EWKT team visits each demo farm weekly to provide technical advise.

#### 3. Peer learning

East-West Seed Knowledge Transfer uses demonstration farms to conduct peer learning sessions on all aspects of sustainable and profitable vegetable production, from land preparation to harvest.

### 4. Field days

Field days are organized for larger groups of farmers on demonstration farms. Also vegetable traders and agro-input dealers are encouraged to attend field days. Aim is to stimulate increased production through disseminating information on market opportunities and availabilities of inputs.

# 5. Extension material

East-West Seed Knowledge Transfer has produced a series of high quality training modules and extension material specifically designed for smallholder vegetable farmers in local languages.
